Articles of Incorporations of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation in compliance with Chapter 617, F.S., do hereby certify:

ARTICLE I

NAME OF CORPORATION

The name of the corporation shall be E. M. Parris, Jr. Ministries, Inc

ARTICLE II

PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be in the City of Orlando, County of Orange, State of Florida. The street address and mailing address of the corporation shall be 5873 Windridge Drive, Winter Haven, FL 33881.

ARTICLE III

PURPOSE

The Corporation is formed exclusively for religious and charitable purposes within the meaning of Section 501 (c) (3) of the United States Internal Revenue Code, or the corresponding provision of any future federal tax code. The corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Code or (b) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Code. The corporation has not been formed for pecuniary profit or gain. No part of the assets, income, or profit of the corporation shall inure to the benefit of its members, council members, or officers. However, the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its religious or charitable purposes.

No substantial part of the activities of this corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation. This corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

ARTICLE IV

MANNER OF ELECTION

The manner in which the directors are elected shall be stated in the bylaws.
