**ARTICLE I- NAME AND ADDRESS**

The name of the Corporation shall be: FONDATION SEGUIN, INC.

**ARTICLE II- PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:  
8410 NE1<sup>ST</sup> Place, Miami, Florida 33138.

**ARTICLE III- PURPOSE**

- A. The Corporation is organized exclusively for charitable, scientific and educational purposes within the meaning of § 501(c) (3) of the Internal Revenue Code, as may be amended. The Corporation is also organized for the purposes of creating sources of revenue to intercede in the destruction forestry and the replacement of forestry.

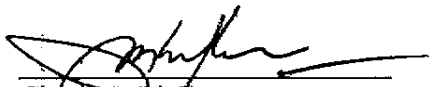

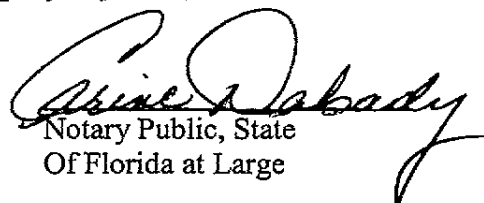
