ARTICLES OF INCORPORATION

OF

VILLA TRIA DOMA HOMEOWNERS ASSOCIATION, INC.

a Florida corporation not for profit

ARTICLE I - Name

The name of this corporation shall be VILLA TRIA DOMA HOMEOWNERS ASSOCIATION, INC.


