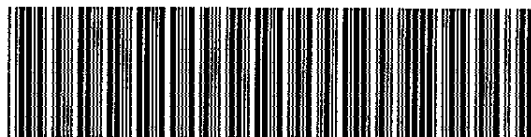

ARTICLES OF INCORPORATION
OF
VILLA TRIA DOMA HOMEOWNERS ASSOCIATION, INC.
a Florida corporation not for profit

ARTICLE I - Name

The name of this corporation shall be VILLA TRIA DOMA HOMEOWNERS ASSOCIATION, INC.

ARTICLE II - Nature of Business

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida, including specifically that permitted by Chapter 617, Florida Statutes; provided this corporation may not engage in any activity for profit and must dispose of all funds on a yearly basis. The purpose of this corporation is to own, manage and control the property owned by the Association, including but not limited to collecting dues, special assessments from unit owners and making disbursements to service providers all as set forth in the Declaration of Restrictive Covenants.

ARTICLE III - Qualifications of Members

The member must be an owner of one of 6 units known as VILLA TRIA DOMA HOMEOWNERS ASSOCIATION, INC.

ARTICLE IV - Term of Existence

The term of this corporation is perpetual.






ARTICLE XI. Principal Office




