The undersigned natural persons, of legal age, acting as Incorporators under the provisions of Florida Statutes, Chapter 617, adopt the following Articles of Incorporation:

**ARTICLE I
CORPORATE NAME**

The name of this Corporation shall be FRIENDSHIP MISSIONARY BAPTIST CHURCH OF YALAH, INC.

**ARTICLE II
PRINCIPAL PLACE OF BUSINESS**

The principal address is 8702 GUAVA ST., YALAH, FLORIDA 34797, and the mailing address is 8702 GUAVA ST., YALAH, FLORIDA 34797.

**ARTICLE III
PURPOSES**

The purposes for which the corporation is organized are: (1) The organization of a Church for religious purposes; (2) to provide a place where Christians can assemble to recognize the Bible, the word of God, and practice the doctrines and teachings of Jesus Christ; (3) to promote and practice that which the National Baptist Association believe; and (4) to serve as a not for profit Baptist Church pursuant to the internal revenue code and all applicable Florida and Federal Laws.

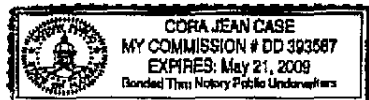


