ARTICLES OF INCORPORATION

The undersigned natural persons, of legal age, acting as incorporators under the provisions of Florida Statutes, Chapter 517, adopt the following Articles of Incorporation:

ARTICLE I CORPORATE NAME

The name of this Corporation shall be FRIENDSHIP MISSIONARY BAPTIST CHURCH OF YALAHA, INC.

ARTICLE II PRINCIPAL PLACE OF BUSINESS

ARTICLE III PURPOSES

The purposes for which the corporation is organized are: (1) The organization of a Church for religious purposes; (2) to provide a place where Christians can assemble to recognize the Bible, the word of God, and practice the doctrines and teachings of Jesus Christ; (3) to promote and practice that which the National Baptist Association believe; and (4) to serve as a not for profit Baptist Church pursuant to the internal revenue code and all applicable Florida and Federal Laws.
