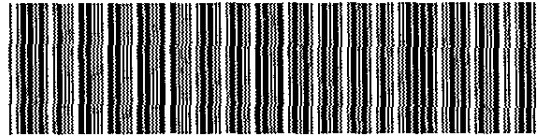

ARTICLES OF INCORPORATION

OF

Eglise Evangelique "Le Jourdain" de la Floride, Inc.

The undersigned in accordance with the provisions of Chapter 617, Florida Statutes, hereby make, subscribe and acknowledge these Articles of Incorporation.

ARTICLE ONE - NAME

The name of the corporation shall be: **Eglise Evangelique "Le Jourdain" de la Floride, Inc.**

ARTICLE TWO - PRINCIPAL OFFICE

The principle place of business is: **19601 NW 12th Court, Miami, Florida 33169.**

ARTICLE THREE - PURPOSES

The purpose for which this corporation is organized as a non-profit corporation in accordance with the provisions of Chapter 617, under the Florida Not for Profit Corporation Act, is to operate an organization that will train and equip people to advance the cause of Christ through ministries that educate, edify and evangelize.

- a) The said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- b) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the County in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE FOUR – MANNER OF ELECTION OF OFFICERS

The members of the Eglise Evangelique "Le Jourdain" de la Floride, Inc. will be entitled to one vote each every two years for the purpose of electing the Board of Directors of the company.

The Board of Directors shall consist of not less than five and not more than seven officers. Officers shall be selected from the members of the corporation.

ARTICLE FIVE - EXISTENCE

The term for which the corporation is to exist is perpetual unless the corporation is terminated pursuant to the terms of the by-laws or any applicable provision of the Florida Statutes.

ARTICLE SIX - INCORPORATOR

ARTICLE SEVEN - HANDLING OF AFFAIRS

The affairs of the corporation are to be managed by a Pastor, a Treasurer, a Secretary and such other officers as the By-Laws of the corporation may provide for from time-to-time. All officers shall be elected at the first meeting of the Board of Directors following the annual meeting of the corporation and shall hold office until the next succeeding election of officers or until their successor are elected and qualified.

ARTICLE EIGHT - INITIAL OFFICERS

The initial officers of the corporation shall be:

President	Rev. Calix Charleston
Secretary	Ms. Marie Julienne Mesidor
Assistant Secretary	Mr. Orinal Enelus
Treasurer	Ms. Guerda Pierre
Officer	Mr. Elie Cesaire

The primary officer shall be the President or the Pastor. The Pastor shall be considered Coordinator of all of its activities. He shall act as chairman of all business meetings of the church and the church Council. He shall be an ex-officio member of all committees and departments. He shall arrange for all services of the church and shall coordinate all special meetings, conventions or revival campaigns.

The Pastor shall be elected in a meeting called for the purpose of his election by seventy-five percent (75%) majority vote, provided, however, that fifty percent (50%) of the active, voting membership of the church is present.

ARTICLE NINE - FINANCES

All funds for the maintenance of the assembly shall be provided by the voluntary contributions or the tithes and offerings and the members and friends of the organization. Offerings shall be accepted by the assembly at such times and in such ways as agreed upon by the Pastor and Board of Deacons, and shall be administered by the Treasury under their direction.

ARTICLE TEN - INITIAL MEMBERSHIP

The initial members of the corporation shall be the persons listed as the initial officers of the corporation and such other persons who may thereafter apply for membership and whose application is approved by a majority of the existing members.



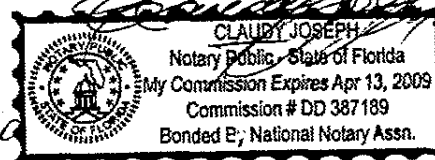
