**ARTICLES OF INCORPORATION**  
In compliance with Chapter 617, F.S., (Not for Profit)

**ARTICLE I**  
**NAME OF CORPORATION**

The Name of the corporation shall be:  
CONGREGACION MESIANICA KOL KORE, CORPORATION.

**ARTICLE II**  
**PRINCIPAL ADDRESS/ OFFICE**

The principal place of business and mailing address of this corporation shall be:  
708 NW 42 STREET  
OAKLAND PARK, FL 33309

**ARTICLE III**  
**PURPOSE**

The purpose for which the corporation is organized is: Exclusively for RELIGIOUS purposes and consist of the following:

- 1- The promotion of the knowledge of the original roots of our faith, into the Jews and Messianic doctrine, and the promotion of disseminating the Good News to all the peoples.  
The maintenance of worship, the edification of believers on Adonai Yeshua , our only God, and for Messianic fellowship and edification.
- 2- Receiving, holding, and disbursing gifts, and funds arising from all sources, exclusively for religious purposes, no part of the net earnings of which inures to the benefit of any private shareholder or individual.
- 3- To do any and all lawful activities which may be necessary, useful or desirable for the furtherance, accomplishment, or attaining of the foregoing purposes , either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, association, trust, institution, foundations or governmental bureaus, departments or agencies.
- 4- Acquiring, owning and maintaining real estate and other personal property, incidental, necessary or proper to carry out said objects.
- 5- All of the foregoing purposes shall be exercised exclusively religious purposes in such a manner that the Corporation will qualify as an exempt organization under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

**ARTICLE IV**  
**LIMITATIONS**

At all times the following shall operate as conditions restricting the operations and activities of the corporation:

- 1- This corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal and state income tax under section 501(c)(3) of the Internal Revenue Code of any future United States Internal Revenue law.

2-The corporation is organized exclusively for religious purposes.

3- The corporation is not organized nor shall it be operated for the primary purpose of generating pecuniary gain or profit. The corporation shall not distribute any gains, profit or dividends to the Directors, Officers or Members thereof, or to any individual, except as reasonable compensation for services actually performed in carrying out the Corporation's religious purposes.

4- The property, assets, profits and net income of the corporation are irrevocably dedicated to religious purposes, no part of which shall inure to the benefit of any individual.

5- No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in any political campaign on behalf of any candidate for public office.

6- Upon winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to an organization recognized as exempt under section 501(c)(3) of the Internal Revenue Code of 1986 to be used exclusively for religious purposes. If the Corporation holds any assets in trust, such assets shall be disposed of in such a manner as may be directed by decree of the Circuit Court of the district in which the Corporation's principal office is located, upon petition thereof by the Attorney General or by any person concerned in the liquidation.

#### **ARTICLE V** **DURATION**

The period of duration for this Corporation is perpetual.

#### **ARTICLE VI** **MEMBERSHIP**

Individuals shall be eligible to membership in this body who give evidence on a personal living faith in Adonai Mashiach Yeshua and who voluntarily adhere to the Tenets of Faith and agree to be governed by its constitution and by-laws as herein set forth.

#### **ARTICLE VII** **MANNER OF ELECTIONS FOR DIRECTORS AND OFFICERS**

The method of selection of the Board of Directors and number of directors/officers, shall be stated in the bylaws.

The officers of the congregation shall be: The Congregational Leader, who also is the Messianic Rabbi and also shall serve as president of the corporation by virtue of his office.


