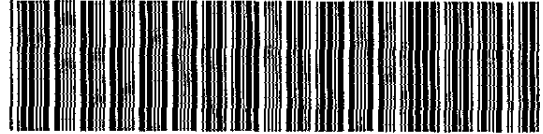

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- a.) To provide a website, called www.ReconcilingFamilies.org, where families can talk to each other, share their stories and use a mediator if requested.
- b.) To provide an alternative to counseling and counselors in the field of psychology, where families have experienced anti-family counseling from professionals.
- c.) To counsel, comfort and provide an intermediary to bring families together.
- d.) To provide counseling services through the support of other families who have gone through similar circumstances.
- e.) To build upon the family as a unit vital to today's kids and our country.
- f.) To provide articles and resources from other families and kids.
- g.) To become the Internet portal for intervention based upon its less invasive nature. Family members do not have to be physically present for discussions between family members to take place. They only need to participate, demonstrating a desire to resolve issues.

Once www.ReconcilingFamilies.org grows , the purpose of the organization could grow as well. That could include the following:

- h.) To borrow money or obtain grants for website infrastructure upgrades;
- i.) To borrow money or obtain grants for persons in need of food, money, clothing, travel and shelter when needed for the purpose of reuniting family members to each other.
- j.) To obtain the services of pro-family counselors and religious experts when necessary.

ARTICLE IV MANNER OF ELECTION

The qualifications of members, the manner of their admission to the corporation, the termination of membership, and voting by such members shall be as follows:

- a) The owner and co-owners of the website shall be members.
- b) Members shall be considered for election based upon their services to the organization.
- c) Voting by members shall be in accordance with the provisions of the Bylaws of this corporation.




