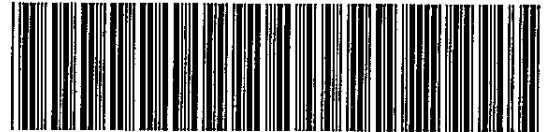

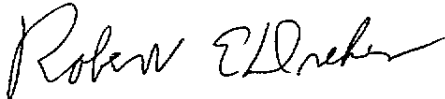

ARTICLES OF INCORPORATION

**ARTICLE I**
