Article VI, Voting, Section 6.2, is amended and restated in its entirety as follows:

6.2 <u>Class B</u>. The Class B member shall be the Developer and shall be entitled to twenty (20) votes for each Lot owned. The Class B membership shall cease and be converted to Class A membership when the total votes outstanding in Class A membership equal or exceeds the total votes outstanding in the Class B membership, or December 31, 2015, whichever first occurs.

Article VII, Board of Directors or Directors, Section 7.3, is amended and restated in its entirety as follows:

- 7.3 Members other than the Developer are entitled to elect at least a majority of the members of the Board of Directors of the Association when the earlier of the following occurs:
- (a) three (3) months after ninety percent (90%) of the Lots have been conveyed to members; or
 - (b) December 31, 2015.

For purposes of this Section, the term "members other than the Developer" should not include builders, contractors, or others who purchase a parcel for the purpose of constructing improvements thereon for resale.

Notwithstanding the foregoing, the Developer shall be entitled to elect at least one (1) member of the Board of Directors as long as the Developer holds for sale, in ordinary course of business, at least five percent (5%) of the Lots in the Development.
