

## CERTIFICATE OF AMENDMENT TO ARTICLES OF INCORPORATION OF RENAISSANCE OAKS HOMEOWNERS ASSOCIATION, INC.

WHEREAS, the Articles of Incorporation of Renaissance Oaks Homeowners Association, Inc. was originally recorded in Official Records Book 15336, Pages 1483 – 1490 of the Public Records of Pinellas County, Florida (hereinafter the "Articles of Incorporation");

WHEREAS, Article XII of the Articles of Incorporation provides that the Articles of Incorporation may be amended by not less than two-thirds (2/3) of the votes of the entire membership of Renaissance Oaks Homeowners Association, Inc.;


NOW, THEREFORE, we, DOUGLAS SPEELER, as President, and RICHARD FRANZ, as Secretary, of Renaissance Oaks Homeowners Association, Inc., do hereby certify that at the annual membership meeting held on November 19, 2014, and reconvened on January 17, 2015, the following amendment to Article XII of the Articles of Incorporation of Renaissance Oaks Homeowners Association, Inc. was duly approved by not less than two-thirds (2/3) of the votes of the entire membership of the Association:

I. Article XII of the Articles of Incorporation of Renaissance Oaks Homeowners Association, Inc., is amended to read as follows:

## ARTICLE XII - AMENDMENTS

Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner.

- 12.1 Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.
- 12.2 A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the secretary at or prior to the meeting. Except as elsewhere provided:



- (a) Such approvals must be by not less than two-thirds (2/3) of the APR -6 PH 1: 27 Members voting in person or by proxy at a duly called meeting where a quorum is represented votes of the entire membership of the Association.
- 12.3 Provided, however, that no amendment shall make any changes in the qualifications for membership nor the voting rights of members without the Developer's approval as long as the Developer owns a Lot in the Development.
- 12.4 A copy of each amendment shall be certified by the Secretary of State and be recorded in the Public Records of Pinellas County, Florida.


