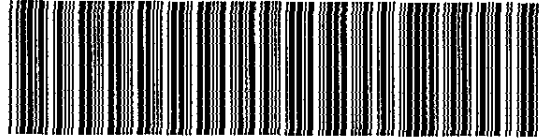

Contribution to which are deductible under section 170 (c) 2 of the Internal Revenue code of 1954 or the corresponding provision of any further united States Revenue Law.

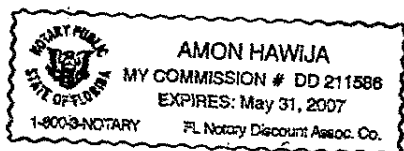
