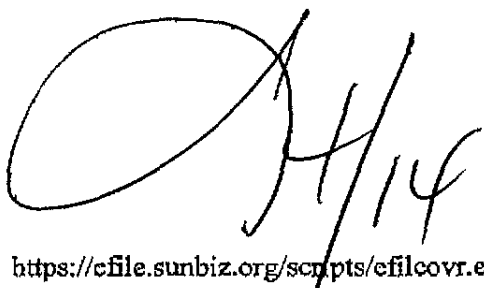

The undersigned incorporator(s) for purposes of forming a corporation under Chapter 617 of the Florida Statutes hereby state(s) as follows:

**I****NAME**

The name of this corporation shall be KNOWLEDGE FOR LIVING, INC. (the "Corporation").

**II****PRINCIPAL OFFICE**

The principal office of the Corporation shall be located at 595 W. Church St. #315, Orlando, FL 32805, but the Corporation may maintain offices and transact business, in such other places within or without the State of Florida, as may from time to time be determined by the Board of Directors. The mailing address of the corporation is P.O. Box 555452, Orlando, FL 32855.

**III****DURATION**

The Corporation shall have perpetual duration.

**IV****PURPOSES AND POWERS**

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article. No substantial part of the activities of the Corporation shall be

the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code or (b) by a Corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**V****REGISTERED AGENT AND OFFICE**

The street address of the initial registered office of the Corporation is: 595 W. Church Street, #315, Orlando, FL 32805, and the name of the initial registered agent of the Corporation at that address is Aminah Hamidullah.

**VI****DIRECTORS**

The affairs and property of the Corporation shall be managed and governed by a Board of Directors composed of not less than three (3), who will be appointed or elected in accordance with the Corporation's Bylaws.

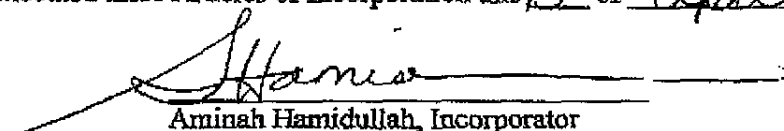

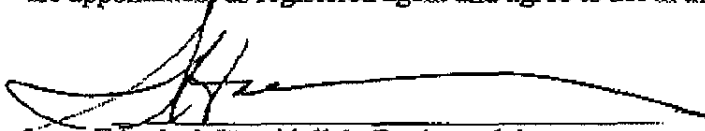
