ARTICLES OF INCORPORATION

FOR

The undersigned incorporator for the purposes of forming a not for-profit corporation under Chapter 617, Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME:

The name of the corporation is **For Seniors Only, Inc.** The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE II - PRINCIPAL OFFICE

The principal address of the Corporation shall be 50 Loggerhead Court, Ponce Inlet, FL. 32127

ARTICLE III - REGISTERED OFFICE AND AGENT

The address of the Registered Agent in the State of Florida is 50 Loggerhead Court, Ponce Inlet, FL. 32127, County of Volusia. The name of the Registered Agent at such address is Karen Butterton.

ARTICLE IV - CORPORATE PURPOSES, POWERS AND RIGHTS

- A. Said corporation is organized exclusively for charitable, religious, educational, and screntific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- B. The general purpose for which this corporation is organized shall be:
- 1. To provide a not for profit internet based company that provides answers to senior citizens on questions about health and other related senior issues as well as to provide hyper links from its site to other internet based information service sites;
- 2. To provide a common arena/location for senior citizens to go to for the dissemination of current health related and/or elderly related information and to provide for the flow of information that would be helpful to them and/or their family members
- 3. In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted to and conferred to a Not for Profit Corporation by Chapter 617, Florida Statutes.

ARTICLE V - INCORPORATOR

ARTICLE VI - BOARD OF DIRECTORS

- 1. The number of members of the Board of Directors may be increased or diminished from time to time by the By-laws; provided, however, there shall never be less than three (3). Each director shall serve for a period of three (3) years with the initial terms being staggered such that one director slot shall come up for reappointment each year. A director shall be appointed or re-appointed by a majority vote of the then existing board of directors.
- 2. If any vacancy occurs on the Board of Directors during a term, the remaining Directors, by affirmative vote of a majority thereof, may elect a Director to fill the vacancy of the empty directors slot.

- 2. If any vacancy occurs in the Officers during a term, the remaining officers, by affirmative vote of a majority thereof, may elect an officer to fill the vacancy until the next annual meeting of the Board of Directors.

ARTICLE XI - NET EARNINGS OF THE CORPORATION

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under
