CHARTER AND ARTICLES OF INCORPORATION

FOR

NEW HORIZON OUTREACH MINISTRY, INCORPORATED

*IN THE NAME OF GOD, OUR FATHER, WE the undersigned, to hereby
associate ourselves together to form and establish a corporation not for
profit under the laws of the State of Florida.*

WE, further, do hereby adopt and agree to the following articles

I

*The name of our corporation, organization or Church (to be used
interchangeably throughout these Articles) shall be called "New Horizon
Outreach Ministries, Incorporated*

II

*The location of our church and principal place of business shall be
5014 N.E. 77th Avenue, Gainesville, Alachua County, Florida.*

III

*The location of the registered office in this State shall be 5014 N.E.
77th Avenue, Gainesville, Alachua County, Florida, 32609. The address of
the registered agent, whose name is Elder Michael E. Griffin.*

IV

*This corporation is organized NOT for profit and the objects and
purpose of this organization is, "To preach the Word of god to every
creature: For all sinned and fallen short of the Glory of God; that
repentance is commanded of God for all and is necessary for forgiveness of
sins; For who so ever shall call on the name of the Lord shall be saved."*

- (a) We shall preach and teach the Word of God, rightly dividing the
word of truth to show others how to grow in Christ, and to lead
them in His holy footsteps as Christ leads us.*

- (b) *We shall be devoted to promoting a spirit of brotherhood and a closer association between the members of the organization respecting and maintaining the Constitution of the United States of America and all subdivisions thereunder.*
- (c) *We shall safeguard and transmit to posterity the purity and righteousness of individual freedom, and the teaching of our God.*
- (d) *We shall assist in charitable work of any nature deemed beneficial and to the best interest of the order and to society as a whole.*
- (e) *We shall raise funds for carrying the same into effect in any manner allowed by the laws of the State, and permitted under the Constitution of the United States of America.*

V

Membership in this organization is open to the public, to all who shall come and partake of the Word of God and accept him as their personal savior.

VI

The duration of this organization shall be forever.

VII

The general officers of this organization shall be the Pastor, Assistant Pastor, Trustees, Deacons and Missionaries.

(a) **PASTOR:** *Shall be the spiritual leader of the church whose job it is, "to be a good shepherd for the sheeps; to lead and guide the sheep in the way that He would have them go; to have and give spiritual sight to the Church in discerning the difference between the spirit of error and the spirit of truth; He shall be elected by the Church to serve until he, resigns, is removed or deceases.*

(b) **ASSISTANT PASTOR:** *Shall assist the Pastor in carrying out his task, and shall serve in his stead when the Pastor is unable to serve. He likewise shall be elected, or removed by the Church.*

(c) **TRUSTEES:** *Shall be responsible for the business affairs and financial needs of Church, such as musical instruments, seating, air*

conditioning. The board of trustees shall not be less than (3) members and shall meet with the Pastor at least twice a month at a time and place designated in the By-Laws for the Church. They shall serve in the same capacity as "directors" of the corporation. They shall be nominated by the Pastor and approved by the membership to serve until they resign or, for good cause, are removed by the board. Additions to the Board for those who resign, or are removed can be initiated by the Board.

(d) **DEACONS:** Shall assist the Pastor in administering to the membership of the Church. They should be trustworthy, exemplifying one who is intent on living a holy life, carrying out the will of God, and the rules of the Church. They shall become deacons, and be removed by the deacon board in the same manner as that provided for the trustees.

(e) **MISSIONARIES:** Shall assist the Pastor in witnessing for God, spreading the Word and carrying for the sick. They shall become missionaries and be removed by the missionary board in the same manner as that provided for the trustees.

(f) Other officers shall be created and their jobs, manner of election, terms, and removal shall be dictated by the By-Laws of this organization.

VIII

The number of initial directors of this organization (who shall also serve on the Board of Trustees and as designated officers of the Church) shall be four (4). The affairs of this organization shall be conducted by directors, whose names and addresses are:

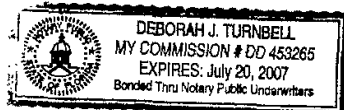
