ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not For Profit)

ARTICLE I NAME

The name of the corporation shall be Pensacola High School Girls Soccer Booster Club, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE
