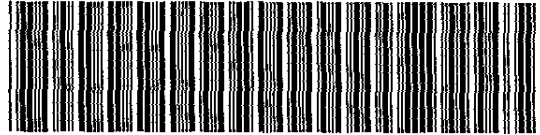

ARTICLE I, NAME






