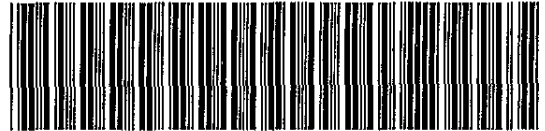

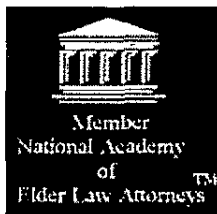

**ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a corporation in accordance with the laws of the State of Florida for philanthropic purposes in accordance with Florida Statutes Section 617, to help to provide for the needs of individuals who suffer from disabilities on the Autism Spectrum, or other related disabilities, which are not otherwise provided for through families, insurance, or government programs.

**ARTICLE I.- NAME**

The name of this corporation is COLLEGE INTERNSHIP PROGRAM FOUNDATION, INC.

**ARTICLE II.-NATURE OF CORPORATION**

The general nature of the business to be rendered by this corporation to help to provide for the needs of individuals who suffer from disabilities on the Autism Spectrum, or other related disabilities, which are not otherwise provided through families, insurance, or government programs. In order to promote its purpose, the Corporation may acquire property by grant, devise, or bequest and hold and dispose of such property as the Corporation shall require for the benefit of the members and purposes of the Corporation and not for pecuniary profit.

**ARTICLE III.-TERM OF EXISTENCE**

This corporation shall have perpetual existence.

#### **ARTICLE IV.-ADDRESS**

The initial address of the principal office of this corporation is: 3716 North Wickham Road, Melbourne, Florida 32935.

#### **ARTICLE V.- DIRECTORS**

This corporation shall have three (3) directors initially. The number of Directors may be increased or diminished from time to time, by By-Laws adopted by the members and shall never be less than three (3). Election of Directors and Officers of the Corporation shall be in accordance with the provisions contained in the By-Laws.

#### **ARTICLE VI.- AMENDMENT**

These Articles of Incorporation and the By-Laws of this Corporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by the Board of Directors, proposed by them to the membership, and approved at a membership meeting by at least a Seventy-Five Percent (75%) vote of the members in attendance at a properly noticed meeting.

#### **ARTICLE VII-MEMBERSHIP**

The membership of this corporation shall consist of the initial Board of Directors and all other persons as from time to time may become members in the manner provided in the By-Laws.

#### **ARTICLE VIII - CORPORATE EARNINGS**

All net earnings of the Corporation shall be utilized to

benefit the disabled children. No part of any net earnings of the Corporation shall ever benefit any member and no member shall ever receive any dividends or profits.


**ARTICLE IX - DISSOLUTION**

In the event of a dissolution of this Corporation, the residual assets of the Corporation shall be turned over to one or more organizations which are themselves exempt as organizations described in section 501 c (3) and 170 c (2) of the Internal Revenue Code of 1986, as amended, or to conform to the Federal, State or local government for exclusive public use.

**ARTICLE X - REGISTERED AGENT**


