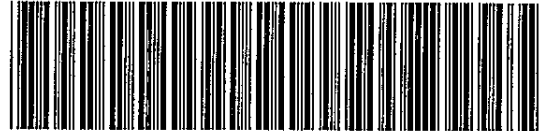

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I:

NAME

The name and address of the corporation is:

ARTICLE II:

DURATION

The term of the existence of the corporation is perpetual.

ARTICLE III:

PURPOSE

Purpose: To communicate by amateur radio in times of emergency, disaster, or other critical incidents and support various organizations involved with public service, safety, health and welfare.

Objectives:

1. To support the public and agencies involved with public safety within Orange County
2. To serve as Amateur Radio Emergency Service and Radio Amateur Civil Emergency Services contact point in Orange County, Florida
3. To support other ARES/RACES organizations when they call for assistance in other geographical areas
4. To support other governmental, public service, or emergency responders in other geographical areas

ARTICLE IV:

MANNER OF ELECTION

NOT FOR PROFIT

This corporation will not be conducted for profit and no part of any net earnings or remainder of dues or donations shall go for the benefit of any member, director, officer, or other private person. This corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose of the corporation as set forth in Article III hereof.

No substantial part of the activities of this corporation shall be propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, this corporation shall not enter into any activities not permitted by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX:
DISTRIBUTIONS AT DISSOLUTION

In the event of dissolution of this corporation, whether voluntary or involuntary or by operation of the law, none of the property of neither the corporation nor any proceeds thereof, nor any

assets of the corporation shall be distributed to any members of the corporation. After payment of the debts of the corporation, the Board of Directors shall distribute its property and assets for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.

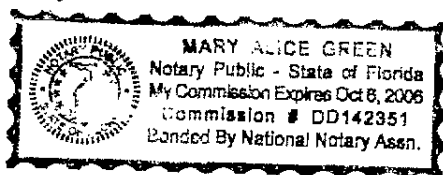
