ARTICLES OF INCORPORATION OF LILLY TOWNHOMES, INC. A Nonprofit Corporation

The undersigned natural person of legal age, who is a citizen of the State of Florida, acting as incorporator of a corporation under Chapter 617 of the Florida Statutes, hereby adopt the following articles of incorporation:

Article I

The name of the corporation is *Lilly Townhomes, Inc.*, (hereinafter the "association").

Article II

The principal office and mailing address of this corporation is 2206 W. 15th Street, Panama City, FL 32401.

Article III

The association is a nonprofit corporation.

Article IV

The period of its duration is perpetual.

Article V

The association is formed for the primary purpose of providing for the maintenance, preservation, and architectural control of the townhomes and common area within a certain tract of real property described as follows:

Parcel 1 - Parcel ID # 06511-000-000

Begin at the point of intersection of the Easterly right of way line of Star Avenue and the Northerly right of way line of Lilly Street, according to plat of Baxter subdivision, as recorded in Plat Book 11, Page 99, of the Public Records of Bay County, Florida and run thence S85°37'44"E along said northerly right of way line for a distance of 330.47 feet to the Southwesterly corner of that certain parcel recorded in Official Records Book 887, Page 14, of said Public Records; thence run N04°28'32"E along the westerly line of said parcel for a distance of 283.94 feet to the Northwesterly corner of said parcel and the Southerly line of a drainage easement; thence run N85°22'00"W along said Southerly line for a distance of 331.15 feet to said Easterly right of way line; thence run S04°20'22"W along said Easterly right of way line for a distance of 284.81 feet to the Point of Beginning. Said parcel lying in and being a portion of the South half of the Northwest Quarter of the Southwest Quarter of the Southeast Quarter of Section 8, Township 4 South, Range 13 West, Bay County, Florida.

and to promote the health, safety, and welfare of the residents.

In furtherance of such purposes, the association will have the power to:

- (a) Perform all of the duties and obligations of the association as set forth in a certain Declaration of Covenants, Conditions, and Restrictions (the "Declaration") applicable to the townhomes and recorded in the public records of Bay County, Florida;
- (b) Affix, levy, and collect all charges and assessments pursuant to the terms of the Declaration, and enforce payment thereof by any lawful means; and pay all expenses in connection therewith, and all office and other expenses incident to the conduct of the business of the association, including all licenses, taxes, or governmental charges levied or imposed on the property of the association;
- (c) Acquire (by gift, purchase, or otherwise), own, hold, improve, build on, operate, maintain, convey, sell, lease, transfer, dedicate to public use, or otherwise dispose of real and personal property in connection with the affairs of the association;
- (d) Borrow money and, subject to the consent by vote or written instrument of two-thirds of each class of members, mortgage, pledge, convey by deed of trust, or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred;
- (e) Dedicate, sell, or transfer all or any part of the common areas to any municipality, public agency, authority, or utility for such purposes and subject to such conditions as may be agreed on by the members. No such dedication or transfer will be effective unless as instrument has been signed by two-thirds of each class of members, agreeing to such dedication, sale, or transfer;
- (f) Participate in mergers and consolidations with other nonprofit corporations organized for the same purposes, or annex additional residential property and common areas, provided that any merger, consolidation, or annexation must have the consent by vote or written instrument of two-thirds of each class of members;
- (g) Have and exercise all powers, rights and privileges that a corporation organized under Chapter 617 of the Florida Statutes by law may now or hereafter have or exercise.

The association is organized and will be operated exclusively for the above purposes. The activities of the association will be financed by assessments on members as provided in the Declaration, and no part of any net earnings will inure to the benefit of any member.

Article V

The street address of the initial registered office of the association is 2206 W. 15th Street, Panama City, FL 32401, and the name of its initial registered agent at that address is Timothy A. Skiba.

Article VI

Every person or entity who/which is a record owner of a fee or undivided fee interest in any lot which is subject by covenants of record to assessments by the association, including contract sellers, but excluding persons holding title merely as security for performance of an obligation, will be a member of the association. Membership will be appurtenant to and may not be separated from ownership of a lot which is subject to assessment by the association.

Article VII

The association will have two classes of voting members, which are defined as follows:

Class A. Class A members will include all owners with the exception of the declarants, as that term is defined in the Declaration. Class A members will be entitled to one vote for each lot owned. When more than one person holds an interest in any lot, all of those persons will be members. The vote for such lot will be exercised as such members determine among themselves, but in no event will more than one vote be cast with respect to any lot owned by Class A members.

Class B. The Class B member will be the declarants, as that term is defined in the Declaration. The declarants will be entitled to three votes for each lot owned. The Class B membership will cease and be converted to Class A membership as provided in the Declaration.

Article VIII

The number of directors constituting the initial board of directors of the association is one, and the names and addresses of the persons who are to serve as the initial directors are:

The method of election of directors is as stated in the bylaws.

Article IX

On dissolution, the assets of the association will be distributed to an appropriate public agency to be used for purposes similar to those for which the association was created. In the event such distribution is refused acceptance, such assets will be granted, conveyed, and assigned to any nonprofit corporation, association, trust, or other organization organized and operated for such similar purposes.
