

ARTICLES OF INCORPORATION

(In Compliance with Chapter 617, F.S., (Not For Profit)

OF

181 (19 P) 3:40 WELL DONE COUNSELING AND PRAYER MINISTRIES, I

ARTICLE I NAME:

The name of the corporation shall be: WELL DONE COUNSELING AND PRAYER MINISTRIES, INC.

ARTICLE II PRINCIPAL OFFICE:

The principal place of business and mailing address of this corporation shall be: 1686 W. Holden Avenue #283 Orlando, FL 32839

ARTICLE III PURPOSE:

The organization is organized exclusively for religious purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The corporation shall conduct any and all lawful activities that may or may not be mentioned above, for the furtherance or accomplishment of the foregoing purposes, provided that such activities would not endanger the Corporation's not-for-profit status under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future Federal tax code.

The specific purposes for which the organization is formed are as follows:

- A. To organize, form and establish a non-denominational ministry; to promote the study of the Bible and other religious works and teachings. To instruct and counsel married couples with marital problems regarding how to solve their problems and love each other, also to instruct and counsel single persons.
- B. To administer healing and comfort in difficult times by one on one counseling and group teachings, through Biblical teachings and prayer and trust., also to teach on personal issues such as: depression, loneliness, anxiety and anger. To hold divine worship service, prayer meetings, Sunday School, Evangelistic Meetings, workshops, seminars. To build and establish educational and physical institutions and preaching of the gospel.
- C. To engage in charitable activities, such as rescue homeless people, and to help those who are in need, to offer general service to benefit the community, and for educational purposes to conduct and operate a religious seminary and school.

D. To perpetuate in the fundamental truths of the word of God and to be divinely commissioned in the task of making all men and women true believers and doers of his commandments, and to embrace the following religious objectives for which the corporation is formed:

To bring to pass the reign of true holiness in the hearts of men.

To consecrate Bishops and ordain Ministers and to authorize same for the promotion of the Christian Religion.

To promote love and Christian fellowship in the membership of our churches and to promote aggressiveness in laboring for Christ's cause. In furtherance of its corporate purposes, the corporation shall have all general powers enumerated in the religious corporation law, together with the powers to solicit grants and contributions for corporate purposes.

To aid the enlargement and dominion of influence of our worker in God's cause, through the establishment of new evangelical church ministries, seminaries and offices throughout the United States and in Foreign Countries in conformity with the purposes herein set forth.

ARTICLE IV MANNER OF ELECTION:

The manner in which the directors are elected or appointed shall be set forth in the Bylaws of Well Done Counseling and Prayer Ministries, Inc.

ARTICLE V DISSOLUTION:

Upon the dissolution of this organization assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.

However, if the named recipient is not then in existence or no longer a qualified distributee, or unwilling or unable to accept the distribution, then the assets of this organization shall be distributed to a fund, foundation or corporation organized and operated exclusively for the purposes specified in Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future Federal tax code.
