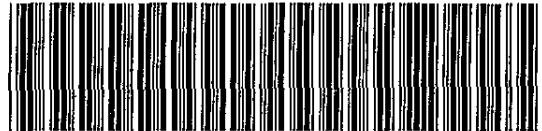

A Florida Nonprofit Corporation

I

The name of the corporation is Barbara's Little Lamb, Inc.

II

The principal place of business and mailing address of this corporation shall be:

III

The purpose for which the corporation is organized is to provide day care and other activities for children.

IV

This corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c) (3), Internal Revenue Code.

- A. This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.
- B. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under section 170(c)(2) of the internal Revenue Code.
- C. No substantial part of the activities of this corporation shall consists of carrying on any propaganda or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.
