ARTICLES OF INCORPORATION OF THE PRESERVE AT LAKE LUCY HOMEOWNERS ASSOCIATION, INC.

The Preserve at Lake Lucy Homeowners Association, Inc., a Florida not-for-profit corporation (the "Corporation") (formerly known as Lakeside at Sunrise Homeowners Association, Inc.) in order to amend its Articles of Incorporation in accordance with the requirements of Section 617.1002 of the Florida Not-For-Profit Corporation Act of the State of Florida, does hereby certify as follows:

- 1. The current name of this Corporation is THE PRESERVE AT LAKE LUCY HOMEOWNERS ASSOCIATION, INC.
- 2. The Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Florida on April 21, 2006.
- 3. The Articles of Amendment of the Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Florida on September 15, 2006.
 - 3. The amendment to the Articles of Incorporation being affected hereby will:
 - (i) completely delete Article 1 thereof and substitute in its place the Article set forth below; and
 - (ii) amend the definition of the "Declaration" set forth in Article 3.
- 4. This amendment is being executed by Centex Homes, a Nevada general partnership, the Declarant in Article 3 of the Articles of Incorporation, and consented to by Pat Knight, the incorporator.
- 5. As amended below, the first Article of the Articles of Incorporation has the sole effect of changing the Corporation's name from "THE PRESERVE AT LAKE LUCY HOMEOWNERS ASSOCIATION, INC" to "PRESERVE AT SUNRISE HOMEOWNERS ASSOCIATION, INC."

- 6. This amendment was approved by Centex Homes, a Nevada general partnership, the incorporator of the Corporation and its only member. on May 9, 2007!

 - B. Article 3 of the Articles of Incorporation of the Corporation shall define "Declaration" as "Declaration of Covenants, Conditions and Restrictions for Preserve at Sunrise."


