ARTICLES OF INCORPORATION
OF
MINISTRY OF DIKINGDOM, INC.

The undersigned, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation not for profit, in compliance with chapter 617, F.S., (Not for Profit).

Article I

The corporate name for the corporation (hereinafter called the "corporation") is
MINISTRY OF DIKINGDOM, INC.

Article II

The embassy or principal office of the corporation is wherever the private and internal flag, banner or emblem is on display in all counties of the State of Florida and in all states of the United States of America, and in all territories thereof, and in all foreign countries as the Overseer shall determine.

The mailing address of the corporation is :

3583 W HILLSBURO BLVD STE 194, DEERFIELD BEACH FL 33442.

Article III

The specific purposes for which the corporation has been formed are as follows:

(a) To act and operate exclusively as the administrative liaison of the Sovereign Body Politic of Dikindom. The function of which is to assist the customary activities of the religious institution. Promoting friendly relations between the sending State and the receiving State, and developing their relations.

(b) To engage in any and all lawful activities and pursuits authorized by Section 501(c)(3) of the Internal Revenue Code.

(c) To acquire and possess, by donation, gift, bequest, devise or purchase, and to hold and maintain church or religious society property, real, personal and mixed, for the benefit of religion, for works of charity, and for public worship, and to grant, sell, convey, rent or otherwise dispose of the same as may be necessary to carry on or promote the objectives of the corporation. To borrow money and to give promissory notes or other written obligation therefore, and to secure the payment thereof by mortgage or other lien, upon real or personal property. To buy, sell, lease, mortgage and in every way deal in real and personal property in the same manner that a natural person may, and without the order of any court. To receive, bequest and devise for its own use or upon trust to the same extent as a natural person may. To appoint attorneys in fact. To contract and be contracted with, in the same manner as a natural person. To sue and plead in all courts of justice. To have and use a common seal by which all deeds and acts of the corporation may be authenticated.

Article IV

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered to the corporation. Assets shall be distributed for one or more exempt purpose to one or more exempt or immune organization or organizations. The corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, as amended or supplemented, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, as amended or supplemented.

The written acceptance of the said initial registered agent is set forth following the signature of the incorporator and is made a part of these Articles of Incorporation.

Such office may be changed at any time by the Minister or Board of Directors without amendments of these Articles of Incorporation.

The name of the initial registered agent of the corporation at the said registered office is:

Article VII

The corporation shall, to the fullest extent permitted, may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify from and against any and all of the expenses, liabilities, or other matters and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled to, both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a Minister, Director, Officer, Employee, or Agent and shall inure to the benefit of the heirs, executors, and administrators of such a person. Directors shall be appointed by the originating or residing Plenipotentiary Minister.

Article VIII

The duration of the corporation shall be perpetual.

Article IX

The corporate existence of the corporation shall begin on the date the original articles of incorporation are file stamped by the State of Florida.
