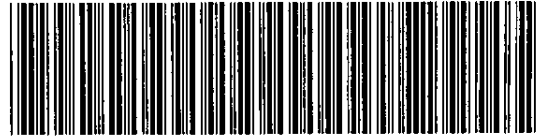

Amended and Restated Article of Incorporation
of
Rollins Moving Services, Inc. (formally known as First Movers, Inc.)
a Not for Profit Corporation

Pursuant to the provisions of sections 617.1006 and 617.1007, Florida Statutes, this Florida Not For Profit Corporation amends and restates its Articles of Incorporation. This Amendment and Restatement was adopted by the members as of November 3, 2015 and the number of votes cast for the Amendment and Restatement were sufficient for approval:

Article I – Name

The name of the corporation is Rollins Moving Services, Inc.

Article II – Principal Office

The principal office and the mailing address of the corporation is Rollins Moving Services, Inc., Rollins College, 1000 Holt Ave., Crummer Graduate School of Business, Winter Park, FL 32789.

Article III – Purpose

The corporation is a not for profit corporation for the purpose of offering moving services, through licensed movers, to students at Rollins College and other colleges. The corporation is run by students of Rollins College for the benefit of student organizations and Rollins College. The corporation will charge fees for these services, but will not earn a profit.

Article III – Members

The members of the Board of Directors of the corporation are the members of the corporation.

Article IV – Board of Directors

The Board of Directors shall consist of at least one member and shall be elected or appointed as provided in the corporation's Bylaws.

Article V – Registered Office and Registered Agent

The Registered Office of the corporation is Rollins Moving Services, Inc., Rollins College, 1000 Holt Ave., Crummer Graduate School of Business, Winter Park, FL 32789. The Registered Agent of the corporation at that address is William A. Grimm.

Article VI – Indemnification of Directors and Officers

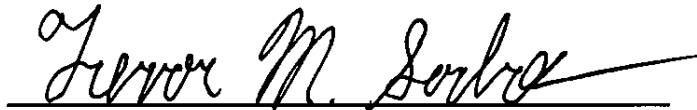

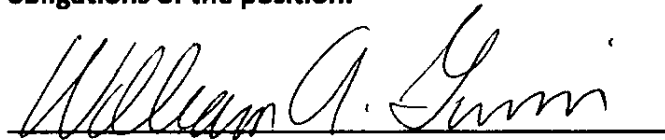
