

The "Coro Sin Nombre" is a Christian Music Ministry that was formed 10 years ago.

The main focus of activities are:

1. Support of the different Church Activities through music. The "Coro Sin Nombre" performs regularly in different Liturgical Celebrations as well as in smaller prayer groups and during Spiritual Retreats.

I has performed in small events of only a dozen people and in also in celebrations with more than eight thousand persons.

It has trained and helped form many Church Choirs in different parishes.

It has served in many fund raising events for different ministries and parishes, however, the "Coro Sin Nombre" does not charge for its services, but rather, it donates its services to whatever event they participate in.

2. It offers its: "Eucharistic Seminar". This seminar is a one full day event that includes music, prayer and Biblical teachings on the true presence of Jesus Christ in the Eucharist.

Up to this point, the members of the "Coro Sin Nombre" supplied their own musical instruments, equipment and expenses as a means of service to the groups and activities it supported.

The Ministry has grown and is being requested to travel to give its seminars and music presentations to many places and will now require that some fund raising be done. In order to allow the accounting of the Ministry to be independent from the personal accounting of the members, we have decided to register as a Non Profit organization.
