**ARTICLES OF INCORPORATION**

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation not for profit under Chapter 617, Laws of the State of Florida, providing for the formation, liability, rights, privileges and amenities of a corporation not for profit.

ARTICLE I

NAME OF CORPORATION

The name of this corporation shall be **SAVED TO SERVE THE LORD MINISTRIES, INC.** with its principal place of business at 113 Daffodil Street, Inverness, Florida 34452 and a mailing address of 113 Daffodil Street, Inverness, Florida 34452.

ARTICLE II

GENERAL NATURE OF BUSINESS

The general nature of the business to be conducted by the corporation shall be for transacting any or all lawful business for which corporation may be incorporated under Chapter 617, Florida Statutes, as now exists or may after be amended. *(Charitable Organization)*

ARTICLE III

POWERS

The corporation shall have all of the statutory powers of a corporation not for profit, except for variances permitted by law which appear in these Articles. The corporation may enter into lease agreements and may inquire and enter into agreements requiring leaseholds, memberships, and other possessory or use interest for terms up to and including ninety-nine(99) years, intended to provide

for the enjoyment, recreation or other use and benefit of the members.

#### ARTICLE IV

##### MEMBERSHIP

The qualifications for members and the manner of their admission shall be regulated as provided for in the corporation's Bylaws.

#### ARTICLE V

##### INCOME DISTRIBUTION

No part of the income of this corporation shall be distributed to its members except as compensation for service rendered.

#### ARTICLE VI

##### EXISTENCE

This corporation shall exist perpetually unless dissolved according to law.

#### ARTICLE VII

##### REGISTERED OFFICE & REGISTERED AGENT

The registered office of the corporation shall be at 113 Daffodil Street, Inverness, Florida 34452, and the registered agent shall be EDWARD W. MITCHELL, JR.

#### ARTICLE VIII

##### NUMBER OF DIRECTORS

The business of this corporation shall be conducted by a Board of Directors which shall consist of not less than two (2) persons and shall be designated by the Bylaws and elected at the annual meeting.

## ARTICLE IX

### FIRST BOARD OF DIRECTORS AND OFFICERS

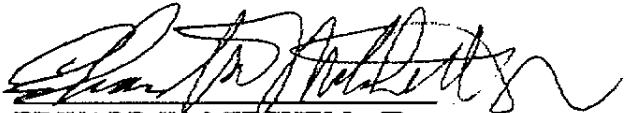
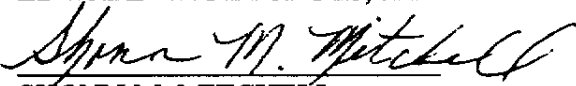

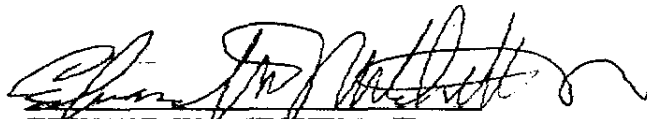
