

## ARTICLES OF INCORPORATION OF SMILEY'S TEMPLE HOUSE OF PRAYER, INC. In compliance with Chapter 617, Florida Statutes (Not for profit)

#### ARTICLE I

The name of this corporation shall be: SMILEY'S TEMPLE HOUSE OF PRAYER, INC.

#### ARTICE II

The principle place of business and mailing address for SMILEY'S TEMPLE HOUSE OF PRAYER, INC. is:

8517 North Palafox Street Pensacola, Florida 32534

#### ARTICLE III

SMILEY'S TEMPLE HOUSE OF PRAYER, INC. is organized for religious and charitable purposes.

- 1. No part of the net earnings of the corporation shall inure to any member of the corporation not qualifying as exempt under Section 501(c)(3) of the Internal Revenue Code, as now enacted or hereafter amended, nor to any Director or officer of the corporation, nor to any other private persons, excepting solely such reasonable compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation;
- 2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office; and
- 3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, as now enacted or hereafter amended.
- 4. Upon the time of dissolution of the corporation, assets shall be distributed by the Board of Directors, after paying or making provisions for the payment of all debts,

obligations, liabilities, costs and expenses of the corporation, for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### ARTICLE IV

SMILEY'S TEMPLE HOUSE OF PRAYER, INC. shall have a voting membership, and may have classes of same, as defined in the corporation's by-laws. The management and affairs of the corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the corporation shall be defined by statute and by the corporation's by-laws. No member or Director shall have any right, title, or interest in or to any property of the corporation. All other directors shall be appointed by unanimous consent of the Board of Directors.

#### ARTICLE V

The initial Board of Directors of SMILEY'S TEMPLE HOUSE OF PRAYER, INC. shall be comprised of the following natural persons:
