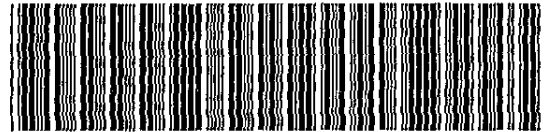

## ARTICLE I: NAME

The name of the corporation shall be: Mid-East Community Aid Program Incorporated.

## ARTICLE II: PRINCIPAL OFFICE
