

# Articles of Amendment to Articles of Incorporation of

Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment(s) to its Articles of Incorporation:

Article II: DELETED - The following are the purposes for which this organization has been created:

To aid the migrant community, providing immigration information services, information of social security,
limited financial assistance for funeral expenses of migrant workers who die in Volusia County,
including funeral services, transportation costs to return the body to their home, to conduct civic
non-profit events for the community and to refer professional services to the community. The organization
shall have exceptions and limitations on financial assistance for medical services, D.U.I. charges, public
intoxication and public utilities. Any member of the community of Volusia County including members
of the Board of Directors requiring the services of the organization shall fill out the application provided.

Article II: ADDED – The organization is organized exclusively for charitable, religious, educational, and/or scientific purposes under section 501 (c) (3) of the Internal revenue Code. The following are the purposes for which this organization has been created: To aid the migrant community, providing immigration information services, information of social security, limited financial assistance for funeral expenses of migrant workers who die in Volusia County, including funeral services, transportation costs to return the body to their home, to conduct civic non-profit events for the community and to refer professional services to the community. The organization shall have exceptions and limitations on financial assistance for medical services and public utilities. Any member of the community of Volusia County including members of the Board of Directors requiring the services of the organization shall fill out the application provided. Note: This narrative description of activities is provided for the purpose of complying with Form 1023, Section Part IV.

Article VI: ADDED – No part of the net earnings of the organization shall inure to the benefits of, or be distributable to, its members, trustees, officers or private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set fourth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda. Or otherwise attempting to influence legislation and organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on by (a) by an organization exempt from federal income tax under section 501 (c), or corresponding section of any federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal revenue Code, or corresponding section of any future federal tax code.

Article VIII: ADDED – Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
