

**ARTICLES OF INCORPORATION**  
**The New Earth, Inc.**  
**A Florida "Not for Profit" Corporation**

The Articles of Incorporation of the undersigned, whom are citizens of the United States, desiring to form a Not for Profit Corporation under the Not for Profit Corporation Law of the State of Florida, do hereby certify:

**ARTICLE I**      **NAME**

The name of the corporation shall be The New Earth, Inc.

**ARTICLE II**      **PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal office of this corporation shall be 1935 Holt Drive, Merritt Island, FL 32952. The mailing address is PO Box 560945, Rockledge, FL 32956-0945.

**ARTICLE III**      **CORPORATE PURPOSES**

The purposes for which this corporation is formed are exclusively educational, spiritual, scientific, and charitable and include the following:

1. To activate a culture of peace on Earth through awakening the peace within individuals, families, communities, tribes, and nations.
2. To live the collective dream and to awaken the world we long for through education, peacemaking, informed action, open dialogue, mediation, outreach, empowerment, inspiration, and building partnerships and coalitions on local and global levels.
3. To organize local and global educational, charitable, scientific, and spiritual programs and outreach projects to facilitate personal and social change at this time of conscious evolution.
4. To build partnerships and coalitions with government, social, civic, religious, spiritual, health, and educational organizations to align with our purpose and build a culture of peace.
5. To honor Mother Earth and share the wisdom that all life is interconnected on this planet.
6. To provide support, resources and educational opportunities to empower individuals to awaken peace within themselves and thereby peace throughout the world.
7. To provide space for like-minded groups and organizations to meet and for them to provide educational, spiritual, scientific and charitable services in alignment with our purpose.
8. To support sustainable economics and lifestyles, to be a steward for Mother Earth, and to promote social justice, unity through diversity, peaceful solutions, gender balance, psychological well being, and dynamic peace building.
9. To bring harmony to Earth through the balance of masculine and feminine energies.
10. To promote leadership in personal and social transformation.
11. To form a community based "think tank" to create innovative solutions and systems in the areas of government, health, religion, education, social justice, social services, the arts, recreation, entertainment, the environment, and land development.
12. To participate in and promote scientific inquiry on peace, spirituality, and related subjects.
13. To promote the expression of the creative and expressive arts as part of the culture of peace.
14. To work with and serve people of all ages, all religions, all spiritual beliefs, all races, all cultures, and all lifestyles as well as all other life forms on Earth.
15. To achieve any other educational, charitable, spiritual, or scientific objectives that may be determined by the Board of Directors.
16. To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, association, trusts, institution, foundations, or governmental bureaus, departments or agencies.
17. To operate solely for spiritual, scientific, educational and charitable purposes and in such a manner that the Corporation will qualify as an exempt organization under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future federal tax code.
  - a. Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from state tax or from federal income tax under section 501 (c)(3) of the Internal Revenue Code, or the corresponding provision of any future federal tax code, or (b) by a corporation, contributions to which are

- deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- b. The Corporation is organized exclusively for educational, charitable, spiritual, and scientific purposes.
  - c. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. The property, assets, profits and net income of the Corporation are irrevocably dedicated to educational, spiritual, charitable, and scientific purposes, no part of which shall inure to the benefit of any individual.
  - d. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
  - e. Upon the dissolution of the corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to an organization recognized as exempt under section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code, to be used exclusively for educational, spiritual, charitable, and scientific purposes. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**ARTICLE IV MANNER OF ELECTION OF DIRECTORS**

The method of selection of the Board of Directors and number of Directors shall be stated in the bylaws.

**ARTICLE VII INCORPORATOR**

**ARTICLE VIII DATE OF INCORPORATION**

The effective date of incorporation is April 22, 2006.
