ARTICLES OF INCORPORATION

OF

SOUTH FLORIDA MUSTANGS SQUARE DANCE CLUB, INC.

The undersigned, for the purposes of forming a nonprofit corporation under the Florida Not for Profit Corporation Act, do hereby make and adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be "SOUTH FLORIDA MUSTANGS SQUARE DANCE CLUB, INC." and the principal address and mailing address is 1629 NE"7Terrace, Ft. Laudendule, FL 33305

ARTICLE II

The corporation is a corporation not for profit as defined in Section 617.02, Florida Statutes (1981). The corporation is not formed for pecuniary profit.

ARTICLE III

The general nature and purpose of this corporation shall be a social club.

<u>ARTICLE IV</u>

This corporation is to have perpetual existence.

ARTICLE Y
