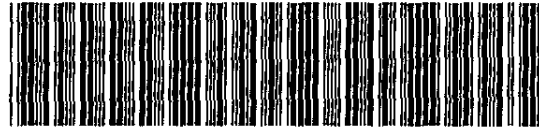

The Undersigned, acting as incorporator of a nonprofit corporation under the Florida Nonprofit Corporation Act, adopts the following Articles of Incorporation, pursuant to Florida Statutes, Section 617, as shown below:

ARTICLE I, NAME

The name of the nonprofit Corporation shall be as follows:

**MILLENNIUM MINISTRY CHURCH OUTREACH, INC.**

ARTICLE II, PRINCIPLE OFFICE

ARTICLE III, PURPOSE

The purpose for which **Millennium Ministry Church Outreach, Inc** is organized are exclusively religious, charitable, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or the Federal, State, or local government for exclusive public purposes.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purposes.
