We, the undersigned subscribers to these Articles of Incorporation, each a natural person, competent to contract, hereby make, subscribe, acknowledge and file these Articles for the purpose of becoming a Corporation not for profit pursuant to Chapter 617.0202, Florida Statutes.

ARTICLE I: NAME

The name of the corporation shall be Lee Davis Neighborhood Service Center Advisory Board, Inc.

ARTICLE II: PLACE OF BUSINESS

The principal place of business shall be in the County of Hillsborough, State of Florida as determined by the Board of Directors. The mailing address is: 3402 N. 22nd Street, Tampa, Florida 33605

ARTICLE III: PURPOSE

The lawful purpose for which this corporation not for profit is organized is as follows:

1. To promote, encourage and evaluate programs, projects and services.
2. To promote meaningful participation by the citizens served in its target area as set forth by Hillsborough County's Health and Social Services.
3. To work jointly with staff in specific areas such as planning, implementation, maintaining programs, problem solving as well as assisting the staff in any way possible.

ARTICLE IV: BOARD OF DIRECTORS

The Board of Directors shall consist of not less than fifteen (15) individuals or not more than twenty (20) members from the community.

The initial Board of Directors shall be elected by the membership at the annual meeting (May) of the membership and each directors shall hold office for a term determined by the board of directors and until his or her successor is duly elected and qualified or until his or her death, resignation or removal from office.

Each person named in the Articles of Incorporation as a member of the Board of Directors shall hold office for an term of one (1) year and until his or her successor have been elected and qualified or until his or her death, resignation, or removal from office. No officer may be elected for more than two consecutive years unless without the majority vote of the membership.

ARTICLE V: REGISTERED AGENT

The registered agent of this corporation shall be Reverend W.D. Sims, 3402 N. 22nd Street, Tampa, Florida 33605.

ARTICLE VI: TERM OF EXISTENCE

This corporation not for profit shall have perpetual existence.

ARTICLE VII: OFFICERS

The officers of the corporation shall be the chairperson, Vice-Chairperson, Secretary and Treasurer and other officers as provided by the By-Laws. The name of the office and the persons who are to serve as officers are as follows:

Vice-Chairperson	Frank A. Reddick
Secretary	LaShonda Phillips
Treasurer	Selphenia Hudson

ARTICLE VIII: BASIS OF OPERATION

No part of the net earnings of the organization shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IX: DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

ARTICLE X: BY-LAWS

The By-Laws of this corporation shall be made by the Board of Directors and may be amended or rescinded as provided therein.


The latest edition of Robert's Rules of Order shall govern all proceedings of the corporation when not covered by the By-Laws.

ARTICLE XI: SUBSCRIBERS



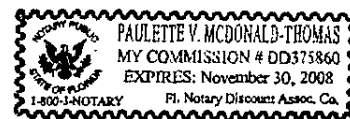
