The undersigned, acting as the incorporator of a not for profit corporation under the Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, as amended, adopts the following Articles of Incorporation for such Corporation:

ARTICLE I. CORPORATE NAME

The name of this Corporation is:

Next In Line Networking, Inc. (hereinafter referred to as the Corporation)

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS OF CORPORATION

ARTICLE III. DURATION

This Corporation shall have perpetual existence unless dissolved according to law.

ARTICLE IV. PURPOSES

The Corporation is organized and operated exclusively for all legal purposes under the meaning of Section 501(c)(6) of the Internal Revenue Code of 1986, as amended. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501(c)(6) of the Internal Revenue Code of 1986, (or the

corresponding provision of any future United States Internal Revenue Law), or (ii) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE V. INITIAL REGISTERED OFFICE AND REGISTERED AGENT


