**ARTICLES OF INCORPORATION
OF
WINGS OF THE MORNING, INC.**

ARTICLE I - NAME OF CORPORATION

The name of the not-for-profit corporation shall be Wings of the Morning, Inc.

ARTICLE II - DURATION

The not-for-profit corporation shall have a PERPETUAL existence unless dissolved according to law. Corporate existence shall commence upon filing of Articles of Incorporation with the Secretary of State for the State of Florida.

ARTICLE III - PURPOSE OF CORPORATION

The not-for-profit corporation is evolved for the express purpose of providing a broad strategic framework of operation that enhances the development and conservation of the community and its resources regardless of race, age, gender, or cultural diversities within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any assets not so disposed of shall be disposed of by the Court of Common Pleas, of the county in which the principal office of the corporation is then located, exclusively for such purposes.

The general nature and objectives of this not-for-profit corporation shall be as follows:

- 1) Assist single parents of the community to improve their living conditions, through professional development courses, housing, job, and childcare enhancements.
- 2) Provide the basic needs to those displaced in the community.
- 3) Develop plans for personal and professional development of the community and citizens.
- 4) Foster, encourage, and oversee structured growth of identified area of the community infrastructure.

ARTICLE IV - INITIAL REGISTERED AGENT AND OFFICE

The name of the not-for-profit corporation's initial registered agent is Vernita E. Davis. The address of this not-for-profit corporation's registered agent and principal place of business is 1703 NW 192nd Street, Miami, FL 33056.

ARTICLE V - OFFICERS AND DIRECTORS

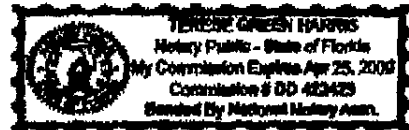

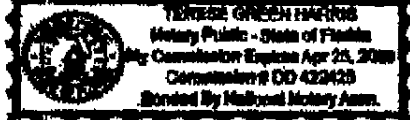
