These Articles of Incorporation are submitted in compliance with Chapter 617 F.S., (Not for Profit) as amended.

ARTICLE I

The name of the corporation shall be Leadership and Public Policy Academy, Inc.

ARTICLE II

The principal place of business and mailing address is: 2900 Sixty-eighth Avenue South, St. Petersburg, Florida 33712.

ARTICLE III

The purpose for which the corporation is organized is to provide experiential learning seminars, workshops and services for young people and other persons interested in public affairs and activities to expand their professional development. The Academy will not discriminate in its programs on the basis of race, gender, national origin, ethnic background or creed.

ARTICLE IV
