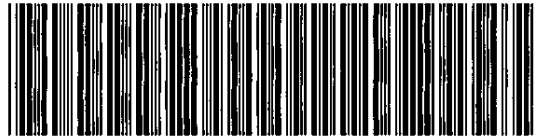

ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporators of a Corporation pursuant to Chapter 647, Florida Statutes, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

NAME

The name of the corporation is Life Line Ministries Inc of Vero Beach, Florida, here in after referred to as the "Corporation"

ARTICLE II

REGISTERED OFFICE AND REGISTERED AGENT

The initial principal address of the corporation is 4301 33rd Avenue, Vero Beach, Florida. C/O 3000 49th Vero Beach, Fl 32967 and the name of the of its initial registered agent at such address is the Reverend Myra L. Ferguson.

ARTICLE III

DURATION

The period of duration of this corporation is perpetual unless dissolved according to law. Corporate existence shall commence upon filing with the State of Florida.


