b) **Orientation about their rights and obligations as immigrants, residents or citizenship of the United States of America.**

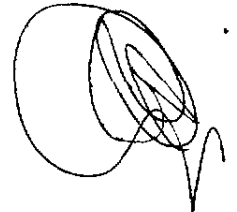
