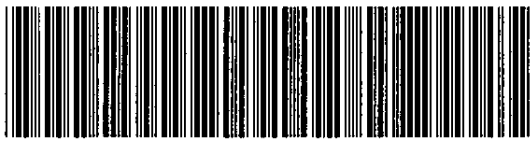

NAME


The name of this Corporation shall be MOUNT ZION CHURCH OF CHRIST, INC.


This amendment was adopted by the entire Board of Directors on April 20, 2009, without shareholder action and shareholder action was not required.
