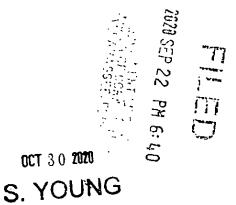

AMENDMENTS TO THE ARTICLES OF INCORPROATION

OF

VILLAGIO DEL MAR HOMEOWOWNERS' ASSOCIATION, INC. a Florida corporation, Not-for-Profit

(<u>Underlined material</u> indicates new language) (Strikethroughs indicate deleted language)

1. Article VII, entitled "Board of Directors", Section 7.2 is amended as follows:

Section 7.2 The affairs of the Association shall be managed by a Board of Directors as provided in and subject to the requirements of Article IV of the Bylaws. Such Board of Directors shall consist of three (3) directors. an odd number of directors with a minimum of at least three (3) directors and a maximum of no more than seven (7) directors. Directors must be Members of the Association. Directors need not be Members of the Association Property. Each Director shall serve for a term from the date of the meeting at which he is elected until the next annual meeting subject to the provisions governing resignation, death, disability, removal and replacement set forth in the Declaration, Bylaws and this instrument.
