

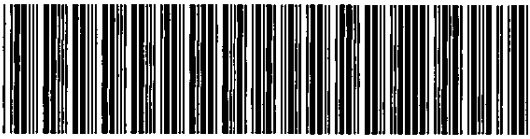

We the undersigned, hereby associate ourselves together for the purpose of forming a Corporation not for profit under Chapter 617, the Laws of the State of Florida, and in accordance with the following Articles of Incorporation.

I

The names of the Corporation shall be:

**MYSTIC TIE COUNCIL NO. 374 ALLIED MASONIC DEGREES, INC.,**

and its initial principal office shall be 9905 SW 90th Avenue, Miami, Dade County, Florida 33176-2963, with the right to change and move said principal office within or without the State of Florida as the Board of Directors may from time to time deem proper.

II

The duration of this Corporation is perpetual. The corporate existence of this corporation shall commence on the date these Articles of Incorporation are executed.

III

The general nature and object of this Corporation shall be the promotion of good fellowship among Free Masons and exemplify the various Masonic Degrees under the authority of Grand Council of the Allied Masonic Degrees, whose headquarters is in Washington,, D. C..

IV

Any regular Royal Arch Mason, may be elected to membership, by a unanimous secret written ballot of the membership taken at a regular meeting of the corporation or at a special meeting called for that purpose, upon the recommendation of a member. The membership shall be restricted to Twenty-seven (27) members.

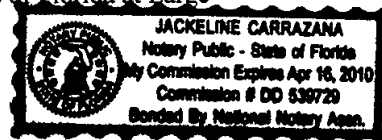
