1. The Articles of Incorporation of the Corporation are hereby amended by deleting Article I of the Articles of Incorporation and inserting in lieu thereof, the following:

"ARTICLE I  
NAME

The name of this corporation is "I Want To Learn English Language Labs, Inc. (the "Corporation")."
