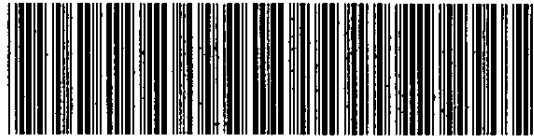


I have also reflected the date on which the amendment was approved and its effective date.
