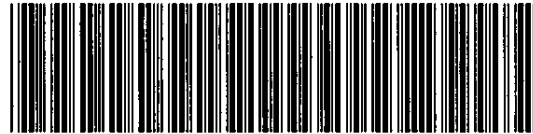



The undersigned incorporator, for the purpose of forming a corporation under the Florida Not-For-Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE
NAME

The name of the Corporation is YOUNG SINGERS OF THE PALM BEACHES FOUNDATION, INC. ("Corporation").

ARTICLE TWO
PRINCIPAL OFFICE

The address of the principal office of the Corporation is 701 Okeechobee Boulevard, Suite 211, West Palm Beach, Florida 33401-6323. The mailing address of the Corporation is 701 Okeechobee Boulevard, Suite 211, West Palm Beach, Florida 33401-6323..

ARTICLE THREE
PURPOSE

- A. The Corporation is organized for the primary purpose of fundraising for long-term, scholarship and education-oriented needs of Young Singers of the Palm Beaches, Inc. ("YSPB"), a Florida not-for-profit organization, which has received Section 501(c)(3) status from the Internal Revenue Service. YSPB trains and provides a high quality choral experience for singers of ages eight (8) through eighteen (18) years of age. The Corporation is also organized for other non-profit

purposes, substantially all of the activities of which are for the aforementioned purposes and no part of the net earnings of which inures to the benefit of any officer or member of the Board of Directors.

- B. In the event of a dissolution of the Corporation, the net assets thereof, after payment or other provision is made for any and all indebtedness and other liabilities of the Corporation, shall be delivered and paid over to an organization selected by the then Board of Directors which qualifies as an Exempt Organization under Section 501(c), or similar section, of the Internal Revenue Code then in effect.

ARTICLE FOUR DIRECTORS

At all times there shall be not less than three (3) Directors of the Corporation. The number of Directors in excess of three (3) and the method of their election is set forth in the Bylaws.

ARTICLE FIVE MEMBERS

The Corporation will have one (1) member, YSPB. The Bylaws of the Corporation contain provisions relating to qualifications for membership, the rights of members, and other such matters.

ARTICLE SIX INITIAL REGISTERED AGENT AND ADDRESS

As set forth in the registered agent's written acceptance of his appointment, which is delivered to the Department of State together with these Articles of Incorporation, the name and




