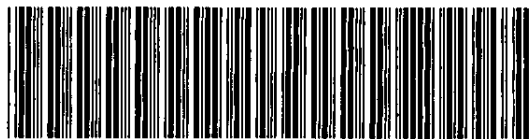

**ARTICLES OF INCORPORATION  
OF  
DAUGHTERS OF VIRTUE MINISTRIES, INC.**

ONE:

The name of the corporation is **DAUGHTERS OF VIRTUE MINISTRIES, INC.** The principal place of business and mailing address of the corporation is 3014 North 12<sup>TH</sup> Avenue, Milton, FL 32583. The corporation is organized pursuant to the Florida, Nonprofit Corporation Code.

TWO:

This **religious corporation** is a church or church controlled organization authorized to transact business, no one may have its name or same name, and it can sue, borrow, and file bankruptcy and more. This corporation is a nonprofit religious benefit corporation and is not organized for the private gain of any person. The corporation is organized under GOD in which we trust in accordance to the 1st Amendment of the United States Constitution and GOD Divine Status (1 Corinthians 12:28). This Religious Benefit Corporation is part of the Church, which is the body of our Lord and Savior Jesus Christ to promote religious activities. This corporation is tax-exempt and can receive tax-deductible contribution as outline in IRS Publication 557 and Application 1023. This corporation is not required to file annually tax returns for church or religious related business. This religious corporation shall establish and carry out business related to but, not limited to: The Religious Creed; By-Laws; Standard Operational Procedures, Divine Doctrine and other related religious activities.

THREE:

The duration of this corporation shall be perpetual, no stock and shall have no members.

FOUR:

The name and address of the registered agent of the corporation shall be:

FIVE:

- (a) This corporation is organized and operated exclusively for Charitable, Religious, Educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code.

SIX:

The property of this corporation is irrevocably dedicated to Charitable and Educational purposes. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Five hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

SEVEN:

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such asset not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.


EIGHT:
