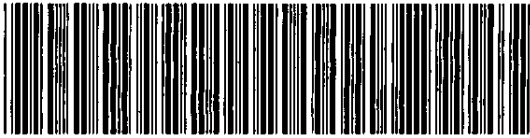


This will serve as an official notice that effective immediately I would like to have my name removed from the list of officers/directors of the "Open Door Baptist Baptist church of Plant City, Inc.
