ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION OF Forever Families Home S

NO6000005622

Pursuant to the provisions of section 617.1006, Florida Statues the undersigned Florida nonprofit corporation adopts the following Articles of Amendments to its Articles of Incorporation.

First: Amendment(s) adopted: Article III being added to previous articles.

ARTICLE III

The corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(C)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The purposes for which said corporation is formed are:
(A) To provide adoption home studies, non-custodial parent home studies, adoption education, post-placement/post-adoption visits and reports, and adoptive and special-needs family support groups, and subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or any part of the income and the principal thereof exclusively for charitable, religious, and educational purposes either directly or by contributions to organizations that qualify as exempt organizations under Section 501(C)(3) of the IRC code and its regulations as they now exist or they may hereafter be amended.

More specifically, these purposes shall include but are not limited to:

- (1) To provide adoption home studies for prospective adoptive parents who wish to adopt a child or children either domestically or internationally.
- (2) To supervise the adoptions through post-placement/post-adoption visits and reports.
- (3) To promote adoption through the use of educational seminars.
- (4) To educate the public regarding adoption through the use of educational seminars.
- (5) To help maintain, preserve, and support adoptive families through support groups and individual and family counseling.

- (6) To help maintain, preserve, and support families of special needs children, biological and adoptive, through support groups and individual and family counseling.
- (7) To help maintain, preserve, and support custodial grandparents the grandchildren they are raising, through support groups and individual and family counseling.
- (8) To assist non-custodial parents who are not involved with the Florida Department of Children and Families with home studies in order to assess their ability to care for their children.

These amendments were adopted unanimously by the Forever Families Home Study Agency Board of Directors on April 14, 2008. There are no members.
