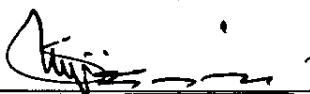

PURPOSE CLAUSE:

- a) Khums Trust is organized exclusively for charitable, educational, religious purposes, within the meaning of section 501(c)(3) of Internal Revenue Code (or corresponding section of any future Federal tax code).

POWER CLAUSE:

- b) No part of the net earnings of the corporation shall incur to the benefit of, or to be distributable to its trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these article, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code(or corresponding section of any future federal tax code)or (b) by a corporation, contributions to which are deduct able under section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code).

DISSOLUTION CLAUSE:

- c) Upon dissolution of this corporation assets shall be distributed for anyone or more exempt purposes within the meaning of the Internal Revenue Code 501(c)(3),i.e. charitable, educational, religious or corresponding section of any future federal tax code, or shall be distributed to the federal ,state or local government for a public purpose.
- d) However, if the named recipient is not then in existence or no longer a qualified distribute or unwilling or unable to accept the distribution, then the assets of this corporation shall be distributed to a fund, foundation or corporation organized and operated exclusively for the purposes specified in section 501(c)(3) of the Internal Revenue Code(or corresponding section of any future federal tax code).
